Pharmacological classification: D. 33.2. Homeopathy. Discipline of the medicine: Homeopathy

This medicine is prepared in accordance with homeopathic principles and is proposed for use in functional disorders in the gastrointestinal and hepatic region; meteorism; disorders after consumption of alcohol, coffee or nicotine.

3. Before you take Nux vomica-Homaccord

Do not take Nux vomica-Homaccord:

If you are hypersensitive (allergic) to active substances or any of the other ingredients of Nux vomica-Homaccord.

Pregnancy and breastfeeding:

If you are pregnant or breastfeeding your baby while taking this medicine, please consult your doctor, pharmacist or other healthcare professional for advice.

Important information about some of the ingredients of Nux vomica-Homaccord:

This preparation contains only very small amounts of alcohol per unit dose. Still, it is recommended that alcoholics consult with a health professional before taking this preparation. A temporary aggravation of the existing symptoms is possible after taking a homeopathic preparation.

Taking other medicines with Nux vomica-Homaccord:

If you are taking other medicines on a regular basis, including complementary or traditional medicines, the use of Nux vomica-Homaccord with these medicines may cause undesirable interactions. Please consult your doctor, pharmacist or other healthcare professional for advice.

4. How to take Nux vomica-Homaccord

Do not share medicines prescribed for you with any other person.

Always take Nux vomica-Homaccord exactly as your doctor has instructed you. You should check with your doctor or pharmacist if you are unsure.

The usual dose is:

Adults: Take 10 drops 3 times daily.

Hold in mouth 10-15 seconds before swallowing. In acute disorders, take 10 drops every 15 minutes for 8 doses.

Long-term administration of this preparation (for several months) must be supervised by a therapist.

Children and infants: Half the adult dose. The drops may be taken in a little water.

It is recommended not to eat or drink 15 minutes before or after taking the medication.

If you take more Nux vomica-Homaccord than you should:

Ingestion of the whole contents of this bottle by a child could result in alcohol intoxication. Treatment is symptomatic.

In the event of overdosage, consult your doctor or pharmacist. If neither is available, seek help at the nearest hospital or poison control centre.

If you forget to take Nux vomica-Homaccord:

Do not take a double dose to make up for forgotten individual doses.
